9 WHEREAS, amendments to the Federal Rules of Bankruptcy Procedure take effect on  
10 December 1, 2009

11 WHEREAS, the Notes of Advisory Committee on 2009 amendments to the Federal  
12 Rules of Bankruptcy Procedure read as follows:


13 The rule is amended to implement changes in connection with the  
14 amendment to Rule 9006(a) and the manner by which time is  
15 computed under the rules. Each deadline in the rule of fewer than  
16 30 days is amended to substitute a deadline that is a multiple of  
17 seven days. Throughout the rules, deadlines are amended in the  
18 following manner:

- 19 5-day periods become 7-day periods
- 20 10-day periods become 14-day periods
- 21 15-day periods become 14-day periods
- 22 20-day periods become 21-day periods
- 23 25-day periods become 28-day periods

24 WHEREAS, the U.S. Bankruptcy Court for the District of Arizona has amended a  
25 number of its Local Rules of Bankruptcy Procedure to be consistent with the amendments to the  
26 Federal Rules of Bankruptcy Procedure (see attached list of amended Local Rules)

27 IT IS THEREFORE ORDERED that the court adopts the amendments to the Local  
28 Rules of Bankruptcy Procedure.
